## EDITOR'S NOTE

I would like to thank those of you who took the time to send comments on the first issue of our Bulletin in the new format - - Rudy Gilster, Jack Goodman, Roger Slobody, Rich & Bonnie Boudreau, and Dan & Paula Randall. Sure helps to know that someone noticed, good or bad.

You will have observed that there are two changes in the directors listed on the opposite page: Region 7's new director, Phil Martz, was tied with Marcia Read in the vote, but Marcia decided simply to withdraw, settling the matter. The other new name is Region 10's Jon Haskins, replacing Wilmer Schmell.

Wilmer Schmell was director of Region 10 for at least 12 years that I personally know of, and probably many years before that. It is sad to learn that health problems prompted Wilmer's decision not to run for the directorship again. Such loyal people as he have kept the Association alive. ### PROGRESS REPORT ON REVISED BY-LAWS

Responsive to a request to her from a member that a particular function of ADCA be addressed in each upcoming newsletter, Lois asked me to explain in this issue our system for election/appointment of directors/officers.

Because the present by-laws are under comprehensive review by a Committee appointed at the last annual meeting and directed to come up with an overall revision thereof, I question whether it is appropriate to do any more at this juncture than to state that under the present arrangement the members of each of the 11 Regions elect, at three-year intervals, one director to serve a three year term - - (these Regional elections being staggered so that either 3 or 4 directors are so elected every year) - - and the officers are appointed each year by the Regional Directors to serve a one-year term. There are several features of the present system which the Committee will consider changing, one being a proposal that there be a method of nominating candidates for election to directorship.

As Chairman of the By-Laws Revision Committee I can report that the views of all of the members (there are 4 on what are considered to be the critical points) have been exchanged by extensive round-robin correspondence, and I am now in a position, and have agreed to put together and circulate to each committee member for their consideration a draft which we can then all work over and, hopefully, come up with a unanimous recommendation. Due in part to the holiday season but more particularly to personal and business commitments which have intervened I have not been able to do anything on the project since Thanksgiving, but plan to turn to it this month so that it will move ahead.

Rosemary has also implemented the use of a computer system for the ADCA which is a feat in itself.


# IMMEDIATE PAST PRESIDENT



## WAYS TO DETERMINE BOVINE PREGNANCY

- I Record-Keeping Reliability of records depends on management.
  - a) A I or service date accurately recorded
  - b) Using 282 as average number of days for bovine gestation.
  - c) Obviously does not account for problem breeders or poor A I techniques.
- II External Indicators
  - a) Abdominal enlargement not always reliable, but more so towards the end of gestation.
  - b) Udder changes as early as 4 to 5 months, but should be noticeable by 7 months.
  - c) Vulvar enlargement 1 to 3 weeks prepartum.
  - d) Pelvic ligament relaxation pelvis widens 1 to 2 days prepartum.
  - e) Colostrum Secretion 1 to 2 days prepartum.
- III Ballottment Feeling fetus through abdominal wall using a bumping-like technique.
  - a) Possible at 5 to 9 months.
  - b) Smaller breeds of cows earlier, larger cows later.
- IV Rectal Examination Palpation
  - a) Performed by an experienced individual such as your veterinarian.
    - 1) Amniotic Vessicle as early as 28 to 45 days postbred.
    - 2) Fetal membrane slip as early as 35 days.
    - 3) Placentomeses as early as 65 to 80 days.
    - 4) Fetus at 70 to 120 days
    - 5) Middle uterine artery 85 to 100 days.
- V Miscellaneous Methods
  - a) Milk progesterone, blood progesterone
  - b) Ultrasound
  - c) Others


