## SUMMARY OF PHONE CONFERENCE BY THE PRESIDENT

Phone conference brought to order January 12, 1992, at 3:00 p.m. Eastern Standard Time.

1. The Board voted to add an amendment to the By Laws concerning Canadian associate members the organization. With this amendment Canada would no longer be a region. Everyone was in favor with one abstention. The ballots are in this Bulletin but on a separate page.
2. There was discussion on whether or not certain animals should be registered. The Board voted to have a regulation written by the Secretary. This would then be sent to the Board who will indicate their approval. The results will be returned to the Secretary and printed in the next Bulletin. All were in favor of this.
3. Annual meeting. Jim Donovan has everything planned and set up.
4. Discussion on whether or not to purchase a word processor typewriter for the Editor. Everyone was in favor of the purchase. The Editor will purchase a typewriter upon approval of the President.
5. The proposition to require that individuals selling semen in our Bulletin to state information about the bull was agreed upon. The following shall be stated: the height of the bull measured in distance from the ground to the top of the shoulder, the bull's weight, and the correct age of the bull at the time the measurements were taken.

Other points of discussion:

Semen transfer information will be available from our secretary.

Rosemary will talk to John Hays concerning the purchasing of his book.

The Board will review photos before any new postcards are printed.

Jim Johnson moved to adjourn the meeting. This was seconded by Rex Kramer and carried at 4:15 p.m. E.S.T.

Should the ADCA drop Canada as a region? This question was brought up at the annual meeting in Texas. I explained to those individuals that I would bring this up for a vote at our phone conference in January. We could not address this situation in our meeting because it was not on the agenda.

The Board of Directors in the phone conference agreed to send the Bylaws amendment out to the full membership to be voted on in our next bulletin.

The amendment to the bylaws will in no way keep Canadians from registering animals in our association. The fees will remain the same as they are at present: the ADCA will lose no revenue or gain any revenue. The only thing Canadians will lose is the right to have a director. The Americans in turn do not have a right to have a director in the CDCA. Again, we are in no way limiting the Canadians in registering their animals.

I received many phone calls from Canadians worried about whether they could register their animals; it seems someone started a rumor that we were going to kick the Canadians out completely. Upon explaining our intent in the amendments, they were very pleased.

I am also very pleased to inform the members that every amendment to our Bylaws will be sent out to the full membership for a vote. Yet, there are still a few individuals who feel we should address problems at the annual meeting. However, this would limit members who cannot afford to attend the meeting and therefore not vote. I am a firm believer in allowing every member the right to vote on important issues and amendments. The days of a few individuals running "our" association are gone thanks to the new Bylaws. You will find a ballot enclosed in this bulletin. Please fill it out and return it to Cliff Heistand on or before April 1, 1992. Please read the Amendment carefully before voting, and should some individual with a biased opinion try to sway your own opinion on the matter, please consider the source before you cast your vote.

## **Regulations for Registering Dexters on which Registration Paperwork Has Lapsed Where Registration Papers Are Not Complete for One or More Past Generations**

It will be necessary to bring up all registrations from the last animals that was shown as a legitimate registered Dexter. Fees for all back registrations of animals (dead or alive) must be paid according to the current fee schedule. If other owners of the animals have been involved on which signatures are required to register the animal in question, fees must be paid accordingly and signatures obtained. The person requesting the current registration paper may choose to pay membership fees (on non-members or the non-member fee for transfer. If any of the original animals' registration papers have been transferred to another member in which transfers to owners have been skipped, the Association reserves the right to recall the registration paper and bring all transfers up-to-date at the cost of the person requesting the present delinquent registration. If pedigree information is missing for any generation, a registration cannot be completed.

If at any time in the paperwork transactions, there is question of parentage, the Association reserves the right to require blood-typing to prove the parentage of the animal in question. The cost for the blood-typing will be paid by the person requesting the registration.

Any questions raised by the Secretary/Registrar on delinquent registrations will be directed to the Regional Director of the Region (or some appropriate ADCA member appointed by the President if said Director is involved) of the delinquent animals involved for clarification. If any questions still arise, the registration of the animal will be held until the Board of Directors can resolve the questions (by requesting blood-typing, etc.)

Any questions on the policy should be directed to either the President or Secretary of the ADCA. If any information is not available or questionable, action by the Board of Directors will be required.

This policy has been approved by the full Board of Directors.

#### Region 4

We have visited with several people in Region #4 lately and we feel we have made new Dexter friends. We have discussed the possibility of having an exhibition pen of Dexter cattle at the National Western Stock Show in Denver, Colorado January of 1993. This is the planning stages so we hope all goes well.

I am very concerned about the proposed BY-law Amendment which you have the ballot for in this Bulletin. Please read it carefully and weigh your decision as there are many conflicts to this.

If we change the By-law to read the way it is written here there is no provision for Canadians or other outside the US to register Cattle with the ADCA. I am told that the Dexter owners outside the US can still register cattle in our registry but possibly at a much higher cost, this is what I am told but it has not been presented to me in written form anywhere. We can not proceed on hear say.

I personally have had contact with several Canadian members. They want to be active members in the ADCA and understand that they can not hold office beyond Director. To be a member of the ADCA is voluntary, therefore, if we leave the By-law as it now stands we are not denying membership to those who want to belong.

I want to share part of a letter from a Canadian member with you. "The cross-border movement of animals is facilitated by ADCA membership. If the status of Canadian members were to change, who would benefit? Not the ADCA as it would lose 10% of its members and revenues. The sale of animals would be impaired by such a move." "In the long term, I would like to see the ADCA as the world-wide Dexter association. There would be much to be gained by such a move. Control of the association need not be removed from the US. All that would be required is a By-law stating that only US nationals or residents may be officers of the association. The only exception would be the directors of those regions outside of the US. There would seem to be need for an association which can gather ideas and information from Dexter owners worldwide. Perhaps the ADCA can be that body."

I agree with this 100%. Let's vote down this amendment change and progress, not regress, toward a new and better worldwide organization.
