It includes all animals registered and transferred between January 1 and December 31. These must be registrations and transfers the secretary receives that 31 since the statement is also done on an annual basis and money must be deposited on December 31. This is not a new If you are unhappy with the herd book being an annual publication, please contact your Regional Director. I have offered to reimburse one member personally since he was very upset that his registrations were received too last. Don't wait until December to send them in.

Also, Please be sure that your white applications for registrations are completed properly. I am getting members who are forging If you do not breed signatures. the animal, you must have the person bred the animal sign the application. Please don't sign that It only delays your person's name. paperwork since the secretary then needs to contact that person. Also, if an animal is transferred three times and no transfers have been completed by the Association, three transfers must be completed. Don't cross off some to save money. If there are calves born during that period, it may cause real problems later. Be sure that all registrations and transfers are kept current-to people that buy your fair Don't expect them animals. straighten out the paperwork.

Be sure to return the information for the herd book to the secretary. If your sheet is not returned, your information will not appear in the herd book.

ARTICLES ON CROSSBREEDING

BY: Shep Springer In a recent issue of our Bulletin

our president stated that he, like probably every Dexter breeder, had an abundance of bull calves. that Bulletin there were at least a dozen and a half bulls advertised. This number is certainly more than is needed to meet the demand of purebred breeders. It seems rather obvious that we need to look elsewhere for a market for our bulls.

Most of us are aware of the success of the Bledsoe Ranch Crossbreeding

Program. This is the use of Dexter bulls on first calf heifers that are of larger beef breeds to eliminate calving problems experienced when breeding the first calf heifers to bulls of the larger breeds. Many Dexter breeders have only a limited number of animals and are probably hobbyist, they do not realize the problem exist. Many of the breeders of larger breeds, who might have 500 or more cows, have to assist with up to 50% of the births. Dexter breeders seldom experience problems and have nearly a 100% calf Among the larger breeds in our area an average of 93% live births is considered good due to the calving problems. I would judge the average calf crop to be about 90%. there are losses of Additionally the heifers themselves if the problem is not identified in time. Their are additional problems of the heifer not rebreeding when there are birthing problems.

The use of Dexter bulls for crossbreeding offers a new market if we just promote it. There is little available data on the Crossbred offspring of Dexter bulls and heifers of the beef breeds. This is an area that we need to address.

From my observation of these crossbreds they will gain at a comparable cost per pound with any other animal. When all factors are equal they will, "Hold their own," when compared. Additionally, the crossbred animal provides beef cuts that are more the size consumers desire.

I am not in favor of an upbreeding program or registration of any animal less than 100% purebred. This program has a single objective which is to produce a marketable beef animal. Lets promote the sale of our bulls for crossbreeding.

One fact we must accept is that we will have to raise these bulls to breeding age. In our area ranchers are willing to pay a good price for breeding age bulls. These same

ranchers will not buy weaning calves even though they might have a substantial savings on the purchase price.

Give this idea a try. It is working for the Springers.
