The 1994 annual meeting of the American Dexter Cattle Association will be held in Region 9, at the California State University, Chico, University Farm, in Chico CA. In addition to the regular meetings and association business, a Dexter Show and Sale for live and videotaped Dexter cattle and a Dexter photo contest will be held.

Dwarfs and Bulldogs

Dr. H.W. Leipold of Kansas State University's College of Veterinary Medicine has agreed to do a pathological study of Dexters for the American Dexter Cattle Assosiation. He will need specimen legs from above the knee of both short-legged and long-legged Dexters that are less than two years of age when slaughtered.

Also, Dr. Leipold needs several bulldog calves (the Dr. has done studies on bulldog dwarfs in the past). Both the complete legs and the bulldogs need to be mailed fresh, not frozen. They should be kept cold until mailing and should be wrapped in plastic bags with a couple of blue ice packs on the sides of the specimen, and then wrapped in a second plastic bag. All specimens should be shipped via UPS to arrive at Kansas State University during the week. Dr. Leipold should be notified prior to shipment.

The Association has agreed to pay for the shipment of the bulldog calf specimens. These specimens need to be sent by **overnight express delivery**. It is **very important** that Dr. Leipold be contacted prior to shipment so that someone can be available to pick up the specimen upon arrival at the University (even on a weekend if necessary). The bulldog specimens are extremely important to the study - that is why the Association has agreed to reimburse the shipping cost to those who are willing to contribute to this study. All requests for reimbursement need to be approved by Dr. Leipold.

DEXTERS GO TO THE CALIFORNIA STATE FAIR.

Bill and Dusty Kirkland want to let readers know that 2 Dexters from their Green River Ranch were exhibited at the 1993 California State Fair. A number of people commented that they had heard of or seen Dexters before, but didn't know how to contact a breeder or the Association. Sounds like we need to continue to make the breed and ADCA more well known.

Some members have requested information regarding an explanation of the EXP (Experimental) Registers from England. Following is a reprint of a letter received from the Breed Secretary of the Dexter Cattle Society.

Dear Ms Fleharty,
Thank you for your letter dated 1st August requesting explanation of the Dexter Experimental Registers. I have enclosed a copy of the explanation as it appears in a rather old and outdated "Rule Book" and this obviously forms the basis of these registers as they have been operated in the past. They were initially set up as part of a carefully planned breed improvement plan which has long since ended.

However, I should draw your attention to the current situation. In order to comply with EEC regulations as an EEC recognized Cattle Breed Society, the Society's registration procedures have and are being upgraded. We have the main purebred full pedigree registers as before. In addition, the "Grading Up" or Supplementary registers now consists of foundation cows (50% registered Dexter parentage and similar to the previous Appendix A). Female calves sired by a registered bull out of a Foundation female are registered as Appendix B subject to passing inspection, and their female calves by registered bulls are registered as Appendix C. Female calves sired by a registered bull from Appendix C dams are then registered in the main purebred full pedigree registers.

No further use is being made of the Experimental registers and where animals are being used which currently carry an Experimental registration these are due to be evaluated and allocated to the appropriate

Appendix registers in accordance with their back pedigree details.

In view of these changes I would suggest some caution be taken in what details are to be given on the old Experimental register system. Our regulations are in the process of being updated and rewritten at present and have yet to be finalized. Details will be circulated to all members in due course.

I hope that these comments will be of use, but please let me know if you require any further details. Sincerely,

EXPERIMENTAL APPENDIX

The experimental may be used by any member on any Dexter cow in the herd, including Appendix A, but not on unregistered animals. All male calves must be steered. All heifers by an experimental bull shall be eligible for entry in the Herd Book in a special E appendix.

A heifer by an Experimental Bull out of an App. A Cow shall be eligible for entry in the Herd Book as an App. B, but with the addition of the letter E.

A heifer by an Experimental Bull out of an App. B cow shall be eligible for entry in the Herd Book as an App. C but with the addition of the letter E.

A heifer by an Experimental Bull out of an App. C cow shall be eligible for entry in the Herd Book in the special E Appendix.

A heifer out of an Experimental Cow by a Purebred Dexter Bull carries the letter E, but her female progeny if also by a Purebred Dexter Bull will be eligible for full entry in the Herd Book, i.e. the granddaughter of an Experimental Cow providing both bulls used were Purebred Dexters will not have the letter E with the entry in the Herd Book.
