NOTICE FROM THE SECRETARY

All members should be advised that herd book information will again be mailed out at the end of the year. All 1994 memberships will be dependent upon the return of this information. If your herd book information is not returned to the Secretary, your membership will not be renewed.

As of Jan. 1, 1994, all applications for registration for heifers over one year and bulls over two years of age must have blood typing of both parents and the animal to be registered included with the application. All blood samples must be drawn by a licensed veterinarian or technician. The blood samples must be submitted to the Ohio State University blood lab and paid for by the member.

It was verified at the 1993 annual meeting that Canadian members are full members of the ADCA. They will continue to be accorded all privileges and rights as they have been in the past. The Regional Director for Canada has been and is Sylvia Stan.

A special thank you to all members who take time to have their Dexters on exhibit at various events and for those of you participating in shows. The Association is getting lots of requests for brochures to distribute at the various events held across the country. This is great news. Also, any media coverage you get is a plus to the Association as well. All of this means that we are getting the word out about Dexters. LETTER TO THE EDITOR

Dear Sir,

It is my understanding that at the recent annual meeting held in Vermont, a member from Canada requested the Board of Directors to implement a regulation that would refuse Canadian members the right to register Canadian born Dexters, unless the animals had first been registered with the Canadian Dexter Cattle Association (CDCA).

This is now the fourth year in a row that this member has tried to have such a regulation passed by the ADCA. I sympathize with this member: The CDCA has lost a third of the Canadian Dexter owners, and over a third of the Canadian Dexter Cattle.

There are good reasons why so many Canadians have chosen the ADCA over the CDCA. Perhaps the CDCA should look closer to home for the solution, instead of asking the ADCA to bail it out.

Annual Meeting Minutes
1993 National American Dexter Cattle Association Meeting
July 17, 1993

The Annual Meeting of the American Dexter Cattle Association was called to order at 7:20 a.m. in White River Junction, Vermont by President Philip Martz.

Those present were: Mr. and Mrs. Charles Betz, Tupper and Sandy Brown, Bonnie Boudreau, Winona Crapp, Carol Davidson, Mark and Marge Davis, Dean and Rosemary Fleharty, Betsy Gaiser, W.B. Goodson, Donna Hutchinson, Thomas and Diane Inman, Jim Johnson, Harry & Billie Julian, Palmer Langdon, Eric Lawlor, Bill and Thelma Lutton, Philip and Druscella Martz, Jim and Jeanne Mitchell, Pat and Linda Mitchell, Jim Moody, Leroy and Helen Oppermann, June Osters, Charles Pacheco, Wes Patton, Amy Record, Paula Simmons, Bob and Kathy Smith, R.S. "Shep" and Mary Springer, Manuel and Sophia Stillerman, Sandi Thomas, Billie and Donna Watkins, and Gary Williams.

It was moved (Kathy Smith), seconded (Shep Springer) and approved to correct the minutes of 1992 to read **Ohio State University Lab**. The minutes were approved with the correction.

A question was raised if the ADCA should be affiliated with a particular blood lab. Sandi Thomas recommended that ADCA be affiliated with a particular lab. It was moved (Dean Fleharty), seconded (Jim Johnson) and approved that the Ohio State University Lab be contacted and that the ADCA affiliation with them be verified.

It was moved (Jim Johnson) seconded (Dean Fleharty) and approved to accept the 1992 annual and 1993 semi-annual income statements.

It was moved (Mark Davis) seconded (Pat Mitchell) and approved to accept the Registrar's report.

The importance of the updating of herd book information was discussed. It was moved (Dean Fleharty), seconded (Carol Davidson) and approved that memberships be renewed for 1994 only if herd book lists are returned to the secretary. The Regional Directors will assist in getting the updated lists returned.

It was moved (Sandi Thomas), seconded (Eric Meyer) and approved that the 1994 herd book (showing 1993 registrations and transfers) be divided into two publications--one booklet will include registrations and transfers only and the other booklet will include membership and associate membership listings and herd listings.

It was moved (Winona Crapp), seconded (Shep Springer) and approved that as of January 1, 1994 any application for registration for a heifer over one year or for a bull over two years old must have blood typing of both parents and the animal to be registered submitted with the application for registration. The blood samples must be submitted to the Ohio State University blood lab for blood typing. A notice of this requirement will be placed in the ADCA Bulletin and other publications.

Wes Patton gave a report from the Science Committee. Dean Fleharty also made a report on a genetic study being made by Horst Leipold of Kansas State University on bulldogs in Dexter Cattle. President Martz appointed Dean to put an article in the Bulletin as well as information in Hornsmatch and the ALBC publication. It was moved (Jim Johnson), seconded (Harry Julian) and approved that

the Association will pay the cost of shipping bulldogs to Dr. Horst Leipold. Members will contact Dean Fleharty for authorization and verification.

Sandi Thomas reported on the study she is doing on color. Sandi would like to receive photos of Dexters with excessive white from any members willing to share them.

It was moved (Wilmer Schmill), seconded (Carol Davidson) that an extension of OC (off color) be added to the registration number if excessive white is beyond the recommended standards of the Association. Standards would need to be changed to meet the definition of what off color would be. It was moved (Wilmer Schmill), seconded (Diane Inman) and approved to table the motion until next year's annual meeting.

Wes Patton shared information on the 1994 annual meeting to be sponsored by Region IX with Wes Patton serving as the host. It will include a live animal show and sale and a video animal show and sale. Standards will be developed for the show next year. These standards will be used only for this show. Wes would like to call this a national show and sale. Everyone in the Association should be encouraged to participate in some facet of the show and sale next year. There will be an entry fee and cash awards for winners. There will also be a photo contest and an udder contest in the photo contest. It was moved (Jim Johnson), seconded (Carol Davidson) and approved that the 1994 national show and sale sponsored by Wes Patton and Region IX would be sanctioned by the ADCA.

President Martz announced that Sally Huff has resigned as editor and Billie Julian has resigned as co-editor of the ADCA Bulletin. The Board of Directors will address the issue of a new editor at Sunday's Board of Directors meeting. A special thank you was given to Sally and Billie for the job they have done on the Bulletin.

Nominations were received for the two directors-at-large to serve at Sunday's Board of Directors meeting. Jim Moody and Donna Hutchinson were nominated. Discussion was held on getting news media coverage for national meetings. Persons holding the meeting should try to get as much media coverage as possible.

It was agreed that a thank you should be placed in the Bulletin for all the members who donate time by exhibiting Dexters or provide any other type of advertising. The Secretary will prepare this thank you.

It was moved (Shep Springer), seconded (Amy Record) and approved that the Association commend Donna Hutchinson for the article she had published in Country Woman.

It was moved (Jim Johnson), seconded (Sandi Thomas) and approved that we accept the lab affiliation with Ohio State University and pay any fee required for the affiliation.

It was moved (Mary Springer), seconded (Jim Johnson) and approved to accept the motion on the updating of herd book listings for 1994.

It was moved (Jim Johnson), seconded (Wes Patton) and approved to go ahead with two booklets for the herd book.

It was moved (Bonnie Boudreau), seconded (Wes Patton) and approved that the motion on bloodtyping of overaged animals be approved with the addition that the cost of the bloodtyping be paid for by the member. It was moved (Bonnie Boudreau) seconded (Harry Julian) and approved to adjourn the meeting until 6:30 a.m. on Sunday.

Adjourned at 12:05 a.m. Sunday.

The meeting was reconvened at 6:45 a.m. on Sunday, July 18 by President Phil Martz.

Embryo transfer registration was discussed. Sandi Thomas will draw up a form that will fit the needs of the ADCA and Jim Johnson will have a veterinarian working with embryo transplants review the form. Sandi will develop a checklist to be sent with the form to be reviewed by the veterinarian and submit an article to the Bulletin upon completion of the form.

It was moved (Jim Johnson), seconded (Amy Record) and approved that the Missouri Dexter Breeders Association be given permission to copy ADCA forms as per request to President Phil Martz.

It was moved (Jim Johnson), seconded (Amy Record) and approved that the request for \$100 for advertising from the Missouri Dexter Breeders Association be approved.

It was moved (Wes Patton), seconded (Amy Record) and approved that the Treasurer stipend (\$500 annually) remain the same.

It was the consensus of the Board that the Secretary/Treasurer Registrar position stay the same with Rosemary Fleharty filling the position(s).

Monthly reports from the Secretary/Registrar/Treasurer will be sent to Regional Directors.

The election of officers was held in closed session. Wes Patton was elected as President and Amy Record as Vice President. Elections will be held in each of their respective regions for new directors.

The Board voiced a vote of confidence for Harry Julian for his work as Vice President and expressed thanks and gratitude to Phil Martz for his service as President.

It was moved (Jim Johnson), seconded (W.B. Goodson) and approved to adjourn at 9:40 a.m.
