ONE MEMBERS' VIEWS

It has been another busy summer at Parkridge Farm. I was slow in getting the ADCA Meeting minutes read. Now that I have read them, I'm disgusted.

It takes a lot of time and money for members to attend ADCA meetings so they can participate in the organization. Reports are good, but should never overshadow input from members of ADCA. At the ADCA meeting, members were allowed to vote on five items - update a pedigree book, approve the minutes for 1993, approve the financial statement, elect Directors-at-large for the 1994 Board Meeting and to adjourn the meeting. BIG DEAL.

After reading the minutes from the Board Meeting, I have some questions. Is this a Democracy or a Monarchy? Fees are doubled without warning. What happened to members' votes, at least those who attended the meeting? Why weren't all Directors informed of the meeting agenda and schedule so they could get feedback from their constituents on all items? I understand not all items were discussed at the Frisay meeting of the Directors. One item was too controversial to be discussed. Was this item a POLLED DEXTER?

I do not understand why anyone that has falsely advocated small Dexters as dwarf would want to register semen from a freak animal, even if it is a pure Dexter.

I believe that, as a dues paying member, Dexter owners and breeders should have more voice in the destiny of the lovable Irish Dexter breed.

From my participation in Missouri Dexter Breeders Association exhibits, I would say that the two most often asked questions about Dexters concern their size and their horns. Most people don't realize that all cattle were small at one time in history and that horns are a natural characteristic. I explain this and add that these two physical traits make the Dexter unique among cattle.

Lets keep Irish Dexters where they were, where they are, and where they will be in the future.

HORNS MAY SAVE A

DEXTER'S LIFE - Don Piehota

In the past, we have debated horns, and arguments in favor of horns have generally centered around points such as: tradition, emphasizing the uniqueness of the breed (proof a Dexter isn't just a runty Angus), an aid in identifying one cow from another at a distance, etc. A new note of urgency now exists, I believe, since pet wolf numbers in the lower 48 states have exploded to about 100,000 pure wolves, and wolf/dog hybrids are estimated at about 400,000 animals. This is not your pack of mongrels or your German Shepherds. This is a killing machine governed by instincts and reflexes, with a reputation that about 90% of these animals eventually attack their owners.

The June, 1994 Smithsonian has a lengthy, colorful article on wolf and wolf hybrids for pets. Even if half true, it should scare the H--- out of a cattle breeder. I will sleep a little

better knowing my cows have horns- not just because they could defeat a wolf or two, but they just might make the meal look so costly the wolf will go on to the neighbor's polled cattle instead.

About 15 years ago, our oldest daughter did a college paper about medieval cattle which typically were as small as Dexters. At that time, wolves were common in all the countries in Europe, yet these small, horned cattle survived the European wolf that even frequently preyed on adult humans.

You can bet we'll soon be hearing about these animals loose in the woods in almost any state. The three year old wolf is fully mature, and when he tries to dominate his owner, some alarmed owner will take him out into the country or woods and abandon him. Include also the nut cases who buy a pet wolf. You can expect quite a few wolf and wolf hybrids set free as part of an amateur plan to once again hear the cry of wolves in the woods of New Jersey, Missouri or Ohio etc.

When I read the Smithsonian article, I was concerned, but three weeks later at an exotic animal auction I attended, four or five crates of wolf pups and young wolves were auctioned off. I looked in one cage containing a nervous young wolf. There is a look about them and a size to them which would convince me to take on a Pit Bull instead. The Smithsonian claims that even animal shelters will not take them, but destroy them immediately because of their dangerousness.

Lets ask some of the folks accustomed to raising their Dexters in or near wolf country in northern Minnesota, Wisconsin, Canada and Alaska for their input. I understand some of them have had to deal with this threat for years, and I would like to know if a horned cow has a better chance of survival.

WHY POLLED?

As F. Chesterley sees it.

My first sighting of Dexters was at the Rare Breeds Survival Trust's show and sale in England, 1983. When I got home I wrote the Association and got a flyer on Dexters. Only one thing wrong with Dexters - they are horned. Sure - you can dehorn them. Every cow I have bought I've had to dehorn. Its expensive and I'm going to step on some toes, but in my book when a breeder doesn't dehorn his calves he is just plain careless and sloppy.

Lets look at it from a personal standpoint. When I got cows I knew that I might be kicked, I might be butted, but somehow I did not cotton to the idea that I should run the risk of being gored. Nor do I cotton to the idea that I should expose my grandchildren, my neighbor's kids, my dog, another cow or the kids' horse to being gored. Its so gorey!

Why give your kids shots for DPT or measles, or why give your cows shots for BVD, Lepto etc? After all, if you did not give them any shots ever, they might not come down with any disease. So it is with horns. As with immunizations, removing the horns is removing the risk, or as my vet expressed it - "you sure reduce the incidence of miscarriages by dehorning." I am sure that someone has a law that states - "If it can happen" and with horns, goring can happen, "it will happen."

I have a book entitled BLUE BOOK OF BEEF BREEDS and it says, about the horned Hereford, that the first imports came in 1817 and there are now over sixteen million registered horned Herefords and these are owned by ten thousand members. The polled Hereford came into being about 1900, and in eighty six years the registrations came to over six million animals owned by twelve thousand breeders. Were we to exterminate all the polled Herefords, I suspect that the breeders would not turn in mass and get horned Herefords. I am

sure that the advent of polled Dexters will broaden the market for Dexters just as the polled Hereford enlarged the market for Herefords.

What is our market? Historically, it has been the retired, the young family with small acreage, and for use in parks and petting zoos. None of these want problems. We have no idea how many might have Dexters but because of horns, opt for some other breed. It isn't that they don't want Dexters - they don't want horns!

I won't have horns! Not only are they an unnecessary threat, but they are just plain ugly. I am sure there are members who feel just as strongly that the Dexter is a horned breed and would even say that dehorning is wrong. Perish the thought of a polled version! Those horns are a thing of beauty! With the coming of polled animals, we Dexter breeders have acquired something very important - freedom to choose. You want horns, fine. You can have them. I want polled, fine. I can have them. Its the way to go!

To: Members of the American Dexter Cattle Association

We exhibited Dexter cattle again this year at the California State Fair. We have been meeting with the management of the fair in regards to having a Dexter class as part of the fair. If the ADCA is willing to sanction the show, provide a list of classes and breed standards, Dexters can be included in the 1995 show.

Now for the tough part. We need a commitment from owners of Dexters to participate in the show. The fair requires a minimum of 30 head and a minimum of 5 different exhibitors. Exhibitors must be the registered owners of the cattle shown and cattle need to be halter broke so they can be shown and judged in the show ring.

The time for showing at the 1995 State Fair would be 4 days - Mon. Aug. 28 through Thur. Aug 31. Entry forms must be received by the Fair

for all Open Livestock Classes by July 28, 1995. This information, along with all the rules and requirements for showing at the fair is provided in the Open Livestock competition handbook which is produced by and available from the fair in May of every year.

As you can see, there is still time for everyone to plan and schedule for this event. **Exhibitors are not limited to residents of California.** Participation by all the members who were at the show and sale in Chico in June showed a real commitment toward promotion of the Dexter breed. Here is another opportunity to promote the breed as well as our Association provided the membership is willing.

We will be happy to get and provide any other information you need to help you to decide about showing at the fair, and we also look forward to hearing from those willing to show.

MESSAGE FROM THE PRESIDENT - WES PATTON

As we go into the final phase of 1994, some issues for members of the ADCA need to be reviewed. First of all, don't get caught up in the increase in registration/transfer fees which will go into effect the first of the year. Check the minutes of the annual meeting, and the special mailing which you received from the ADCA. Remember, the reason for the increase in fees is not a penalty, rather a way of increasing the association income to support the services we all expect. Use this opportunity to get any of your Dexter homework caught up before the end of the year.

Some of our members have contacted me in regards to some of the decisions made by the Board during the Annual Meeting. One issue is the acceptance of a polled bull for semen sales to members of the ADCA. I have reviewed the discussion surrounding the decision, Rosemary has contacted the English association for background information, and I have responded to those members who have registered concerns. Perhaps one of the letters will be included in a future Bulletin. Although everyone has their own opinion, the board acted on the fact that there appears to be nothing in our requirements for registration which would prevent the registration of a polled animal. However, this animal must meet the requirements for semen sales, which includes blood typing.

Pat Mitchell is making plans for the 1995 annual meeting in Michigan. If you have some ideas for things you want to include in the meeting, please send them off to Pat. Time may not permit including everything, but Pat will sort through the ideas and include as many as possible.

I attended the Canadian meeting in November, and I hope that our associations can work together to take ideas to the meeting in England next September, which is being called to establish a world federation for Dexter Cattle. This should help all Dexter associations develop uniform standards and solve common problems.

Just a note to update current events in western Kansas and the Oklahoma panhandle. Have been able to recruit new members into the Association and move all my 1993 bulls into breeding herds throughout Texas, Oklahoma, Colorado, Kansas and Michigan.

We are looking forward to 1995 and the gaining popularity of the Dexter breed. There was a very nice article in the Southwest Stockman and Record Stockman out of Denver. Its nice to be in on the ground floor of a moving breed.

Thanks to the people who bought Dexter breeding stock from Smiling Johnson Dexter Headquarters in 1994.

FULL SET OF ENGLISH DEXTER HERD BOOKS NOW IN NORTH AMERICA

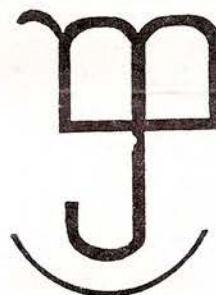

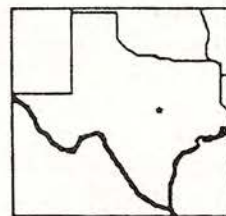
