Another Opinion

In the January / February issue of the bulletin, there are a number of letters about both the polled aspect and the fee structure. I will treat the polled comments.

Mr. Johnson, "A polled Dexter has to be crossed --". No, mutations have existed down through the ages. Most mutations are lethal. I can only guess that polled mutation was lethal until man wised up and protected the polled animals. It was his advantage to do so. Today scientists can not only tell you that there are mutations, but that in a population of say ten thousand horned European cattle, you can expect so many polled mutations. It is that well researched.

In England there are two strains of polled Dexters. One is due to breeding up and the family tree shows EX on the animals that were used for breeding up. The other line there is no breeding up, and the family tree is clean of all EXs. The semen we brought in is from the non EX line.

the Incidently, I have greatest respect for the Brits and their saving the Dexters. The breed was almost gone when the Rare Breeds Survival Trust took on the task of saving the breed. Because numbers were so low they allowed breeding up, but they established standards, Dexter standards - size, docile, easy calving, dual purpose, and hardy. Today the majority of British Dexters are what are called middle legs. They aren't dwarfs, nor are they long leg Kerry. The Brits have done just what the Chico geneologist told us some years ago, "If you want a small animal that breeds true, take your proportionate animals and breed down, you will never get it from dwarfs."

Mr. Johnson also says that we don't need polled animals, we accomplish the same with dehorning. Look at it this way, you can remove horns either surgically or genetically. Surgical removal is a shock to the animal, it costs money, and there is always the risk of infection. Put very simply, Mr. Johnson, which would you prefer, to be born with a mole that has to be surgically removed, or to be born without a mole? Another point you might think about is that there are animal rightists and humane societies that regard dehorning as inhumane. With all the other nutty laws that have been passed, we may find that we suddenly can't surgically remove horns.

Ms. York is concerned as to how she can be assured that she won't corrupt her horned animals by inadvertantly getting a polled animal. The answer is that polled animals carry a letter "P" after their registration number. Also, the genetics for polled follow the same rules as color. If you have dun cows and use a dun bull, you will get dun calves. In other words, if a calf has horns, it does not have the polled gene. Like black, the polled gene is dominant. However, using horned on horned doesn't guarantee that you won't get a polled calf. Mutations are like lightning and you never know where or when it will strike next

As for toothless dogs, I haven't got any. My dogs have their teeth, but I don't have a Doberman, a Rottweiler, Pitbull, or wolfdog!

Getting back to a more serious vein, just because you have had gentle, docile, easily handled Dexters doesn't mean that it is going to stay that way. Some years ago a bull was imported that was genetically vicious. He was a Jersey in disposition. He has sons who have made a reputation, and now there are grandsons. Yes, he is on A.I. and available from coast to coast. So watch it!

As I read the letters, I have a feeling that somehow people regard the polled version as an attack against the horned. The argument isn't about the right to remove the horns, that has already been decided. The argument is about how the horns are to be removed. Those wanting horns aren't affected.

Just a note with a couple of ideas. First being on horns verses dehorned.

If a member has a fear of horns, or prefers dehorned animals, great. Dehorn them. That's their choice. Our family prefers horned animals. Great, leave them on. This is our choice.

We have raised Dexters for 5 yrs. We have three daughters ages 15, 12, & 9. We have never had a cow or bull intentionally or unintentionally gore one of us.

Like with any breed of animal, there are always differences in the characteristics people like. Everyone can have their own likes without pushing theirs on someone else.

If polled animals are to be, then have a separate division or registry for these animals. That way we can be assured of getting the characteristic we like.

One other idea on raising funds for ADCA would be merchandising t-shirts, sweatshirts, hats, etc. I know this helps in other breed associations we belong to.

Polled Dexters

A hot topic right now in the ADCA is the subject of polled Dexters.

To give you a broader, international outlook on polled: South Africa has been registering polled Dexters all along, but only recently started to register longlegs. There is more controversy in England over duns than there is over polled. A European country wants only polled Dexters. One of the first purebreds imported into Australia was polled. The U.S. has accepted polled Dexters (in part because every possible precaution had been taken to prove mutation, not crossbreeding), and protects its members by adding a "P" at the end of the registration number to identify all polled animals--decided at the '94 Directors meeting the morning after the AGM.

Two more purebred Dexters who appear to be genetic mutations for polled have surfaced: no previous crossbreeding, both parents horned, reputable owners. These animals will all be bloodtyped, and if they prove out, well, they are truly mutations, too.

In all things, opinions and standards change, and what was wrong last week is 'in' this week, and can be passe next week (take the bitter fight to establish Red Angus and Polled Herefords, for example). And, don't forget that up 'till now, over other issues, members of the ADCA have insisted on their right to 'do their own thing', without controls.

Maybe we need to take another look at polling. No, you can't assume polleds are crossbred. Yes, it's a change. Some want it, some don't. No one is MAKING owners go polled. Live and let live, I say.


