- 1. Lesa welcomed everyone and after roll call the BOD went into an executive session for 30 minutes.
- 2. Bulletin -
 - The BOD was made aware of editorial mistakes in the Dexter Bulletin. The BOD discussed how to make amends to members. Jim Woehl's made a motion, Robin Welch 2nd, to extend the Coad's advertisement in the Dexter Bulletin by one edition beyond what they have already paid for. The motion was passed unopposed. by the BOD.
- 3. Bylaws Pat Mitchell
 - Pat Mitchell made a motion, Becky Eterno 2nd, for the BOD to accept the revisions to the Bylaws and adopt the revised and amended Certificate of Incorporation as presented from the Bylaw committee. The motion was passed unopposed by the BOD.
