7. Registration and Software Task Force update –

- The progress made so far is incredible, but Susan Smythe does not anticipate having Phase 1 ready by the December BOD meeting. Her plan is to present it at the Feb 2021 BOD meeting.
- Import of the current data needs to be as accurate as possible; data problems have been identified dating back to the beginning of the registry concerning duplicate names, bad registration numbers and issues with bad foreign registry numbers.
 - Jeff Chambers made a motion on behalf of the registration task force, Emily Boeve 2nd, for the registration and software task force to have the ability to make recommendations to the registrar to make changes in these three specific areas to correct errors. Any certificates re-issued due to corrections will be done at no cost to membership.
 - The BOD voted to suspend the 5-day rule for voting on this motion due to its importance. The motion carried.
